This Master Agreement effective as of May 1, 2018 by and between Maharashtra Academy for Engineering and Educational Research's (MAEER's) Maharashtra Institute of Technology Academy of Engineering (MITAOE), Alandi (D), Pune, an Indian Non-Profit Educational Organisation with a principal place of business at Alandi (D), Pune 412105 and Trustees of Boston University ("BU"), a Massachusetts nonprofit corporation with a usual place of business at 808 Commonwealth Avenue, Boston, MA 02215, U.S.A, through its Metropolitan College International division.

WHEREAS BU and MITAOE recognize the mutual benefits of scholastic interaction between them; and

WHEREAS MITAOE wishes to offer its students the opportunity to study at Boston University and BU agrees to host MITAOE students for the purpose of studying at Boston University;

NOW, THEREFORE, in consideration of the mutual agreements herein contained, and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

**1. THE MET INTERNATIONAL PROGRAMS**

The Programs are described in Program Term Sheets that may be entered into by BU and MITAOE from time to time, any such Program appearing on such Program Term Sheet hereinafter referred to as a "Program."

**2. FEES**

2.1. Tuition and fees for each Program will be set forth on the Program Term Sheet. Tuition and other BU student fees shall hereinafter be referred to collectively as "the Program Fees."

2.2. Each student shall pay the Program Fees in full to BU no later than fifteen (15)




2. Appropriate course selections, including satisfying all course requirements and prerequisites as necessary.
3. Selects 2 courses (8 credits) in one term or 3 to 4 courses (12 – 16 credits) over both terms to comply with F-1 visa guidelines.
4. Proof of immunization against the following communicable diseases: measles, mumps, rubella (MMR), tetanus-diphtheria-pertussis (Tdap), hepatitis-B, varicella, and (bacterial) meningitis. Proof of the MMR must be submitted to Boston University Summer Term with the participant's application materials. Proof of the other required immunizations must be provided prior to the start of classes. Additional immunizations and a tuberculosis skin test may be required for on campus accommodation or depending on country of origin and tuberculosis history.

Five months prior to the Program start date, MITAOE will provide BU a tentative list of students or projected enrollments.

**PROGRAM FEES:**

Boston University will provide each participant studying full time in the Boston University Summer Term Program a grant in the amount of 15% of the then current tuition. Each participant studying full time in the Boston University Summer Term Program will pay the then current Boston University Summer Term tuition less the amount of any grant awarded, plus then current student fees in full to Boston University according to the then current Summer Term payment dates. Boston University's then current course withdrawal and refund policies will apply.

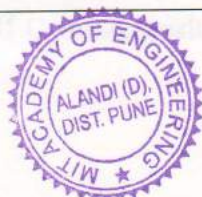

**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding ('MoU') is by and between the

**University Court of the University of Aberdeen, a charity registered in Scotland, No SC013683,  
University Office, King's College, Regent Walk, Aberdeen, AB24 3FX, United Kingdom**

**And MIT ACADEMY OF ENGINEERING [MITAOE], Alandi (D), Pune, 412105, India**

and who may, from time to time, be hereinafter referred to individually as the 'Party' or collectively as the 'Parties'.

WHEREAS, the Parties are mutually interested in establishing collaboration on academic and research related development activities;

WHEREAS, the Parties have discussed the furtherance of these interests and now desire to record their mutual understanding in this regard;

NOW THEREFORE the Parties agree to enter into this MoU as follows:

**ARTICLE I: PURPOSE AND PRINCIPLES OF COLLABORATION**

The purpose of this MoU is solely to detail the intentions of both Parties in order for them to evaluate the possibility of developing collaborations in the activities detailed under Articles II and III hereunder. Such activities shall be further developed and materialised only under a separate written legally binding agreement as detailed under Article IV.

**ARTICLE II: AREAS OF COLLABORATION**

The primary areas of collaboration are in the fields of Engineering Science Education (Undergraduate and Postgraduate Teaching and Research).

Other areas can be added by written agreement of the Parties which is only valid by signature of an authorised signatory of each of the Parties.

**ARTICLE III: METHODS OF COLLABORATION**

The Parties shall jointly develop activities to enhance their academic and research capabilities for the benefit of both Parties. Each activity will comprise of:

1. Encouragement of exchange of academic colleagues and of students;



2. Development of joint, comparative, research projects, technical services, training, consultancy and related activities;
3. Pursuit of funding in order to enable such activities.

(hereinafter referred to individually as 'Activity' and collectively as 'Activities')

Both Parties will actively pursue funding in order to enable the above Activities.

#### **ARTICLE IV: IMPLEMENTATION**

The specific Activities shall be further developed and materialised only under a separate written legally binding agreement for each Activity when an Activity will be organised jointly by the Parties.

Both Parties will determine the feasibility of each Activity according to their requirements and enter into a separate written agreement prior to its implementation, such agreement shall consist of the legal obligations and responsibilities of both the Parties relating to the management and organisation of the Activity, including but not restricted to:

- the start date, duration and end date of the Activity;
- fees, maintenance and expenses, where applicable;
- the policies and procedures relating to admission, registration and statutory reporting;
- the policies and procedures relating to academic standards, and for monitoring, assessment, examination and award;
- the facilities and academic and pastoral support available, including the avenues for appeals and complaints;
- the monitoring, review, ownership, management and exploitation of Intellectual Property;
- the surviving obligations of the Parties following termination of the Activity.

Each Party will nominate a representative to supervise that Party's involvement in an Activity. The name and contact details of said representatives will be issued to both Parties.

#### **ARTICLE V: NON COMMITMENT**

1. This MoU does not commit either Party to any financial expenditure. Activities will be initiated only if the necessary support funding has been guaranteed and a separate written legally binding agreement has been entered into by both Parties.
2. No student is allowed to enter into any collaborative programme solely on the basis of this MoU.
3. This MoU is not intended to create a contractual relationship between the Parties, nor shall the terms of the same be considered legally binding upon the Parties.


**ARTICLE VI: DURATION AND TERMINATION**

1. Either Party may terminate this MoU in giving not less than sixty (60) days' notice in writing of termination.
2. This MoU shall continue in force from the last date of signature of this MoU and effect for a period of three (3) years, unless terminated earlier under Article VI (1).

**ARTICLE VII: LANGUAGE**

This MoU is drawn up in English which language shall govern all documents, notices and meetings for its application and/or extension or in any other way relative thereto.



# AGREEMENT FOR COOPERATION

BETWEEN  
MIT ACADEMY OF ENGINEERING  
AND  
UNIVERSITY OF DAYTON

---

1. The MIT Academy of Engineering in Pune, India and University of Dayton, in desiring to develop academic exchange and cooperation in teaching and research for the advancement and dissemination of learning, agree as follows:
  - A. To allow and use their best endeavors to affect visits from one university to the other by members of the academic staff for the purpose of participating in joint teaching, joint research, joint conferences and joint cultural programs.
  - B. To offer admission from one university to the other to qualified students to undergraduate and graduate courses.
  - C. To encourage the exchange of scientific materials, publications and information.
  - D. To prepare, as necessary, additional working programs detailing specific forms and contents of cooperation.
2. The universities agree to provide exchange faculty members with proper academic status at the host institution, research facilities, access to university libraries, and other assistance and advice when necessary.
3. The universities acknowledge that all visits of staff and admissions of certified students will be subject to compliance with the entry and visa regulations of India and the United States, and the university requirements with respect to staff appointments and student admissions.
4. The universities understand that any additional financial arrangements will have to be negotiated and will depend on the availability of funds.
5. The universities agree to supply regularly to the other information and material about academic offerings and requirements for exchange students.




6. The Agreement shall remain in effect for an initial period of five years. Thereafter, except for any notice to terminate it, it shall be automatically renewed. However, it is understood that either party may end this agreement anytime by mutual consent or by six months notice.







**ARTICULATION AGREEMENT BETWEEN DUNCAN OF JORDANSTON COLLEGE OF ART AND DESIGN, UNIVERSITY OF DUNDEE AND THE MAHARASHTRA ACADEMY OF ENGINEERING AND EDUCATIONAL RESEARCH, MAHARASHTRA INSTITUTE OF TECHNOLOGY (MIT) INSTITUTE OF DESIGN, PUNE**

**Parties to the agreement**

1. The parties to this agreement are:
  - a. The Duncan of Jordanston College of Art and Design, University of Dundee, Nethergate, Dundee, DD1 4HN, hereafter referred to as UOD a Scottish Registered Charity No SC015096.
  - b. The Maharashtra Institute of Technology (MIT) Institute of Design, Pune, hereafter referred to as MITID.

**The nature of the agreement**

2. This agreement makes provision for articulation between specified academic programmes provided by the MIT and specified academic programmes provided by Duncan of Jordanston College of Art and Design, UOD leading to an academic award from the University of Dundee
3. Achievement by students at MITID may be recognised by UOD, which may grant specific credit towards specific towards academic awards at the UOD.
4. This agreement:
  - a. Relates only to the provision, and arrangements to be agreed. These will be set as "Articulation Arrangements", to be added as an Annex to this agreement.
  - b. Does not signify any other accreditation, validation or approval by UOD of standards, quality, or services provided by MITID.

**General responsibilities of both parties**

5. Each party will co-operate in a spirit that is honest and open.
6. Each party will only be liable for its own acts and omissions.
7. Each party is required to act only within its powers and constitution and each shall solely be liable for any breach of this requirement.

**General responsibilities of MIT**

8. MITID is responsible for the standards and quality of its provision and for all services to its students.
9. MITID will advise UOD in advance of any proposed changes affecting standards, quality, learning resources, or student intake associated with the provision stated in the section "Articulation arrangements" below. UOD will have the right to review the terms and conditions of this agreement to reflect any such changes.







**Period of validity of the agreement**

- 35. This agreement will be valid for a period of three years from date of first signature, covering student admission to UOD in academic years 2010-2012.
- 36. The effectiveness of the collaboration will be reviewed by both parties no later than six months prior to the scheduled expiry date.
- 37. The collaboration may be extended or renewed by mutual agreement following the review.

**Termination and disputes**

- 38. Either party may terminate this agreement by registered letter giving 12 (twelve) months notice.
- 39. Following receipt of such notice:
  - a. The termination process would be planned in ways that take account of the concerns and situation of students.
  - b. UOD would honour all formal admissions offers that it had made to students of MITID
  - c. UOD would consider applications of any students who had commenced their studies at MITID on an individual basis.
- 40. Should any dispute arise relating to this collaboration the respective Link Co-ordinators will attempt to seek resolution acceptable to their organisation and shall seek to resolve tensions and conflict directly and collaboratively. Should the Link Co-ordinators fail to achieve resolution, the issue will be referred to independent mediation.
- 41. The mediator, mediators and/or mediation service shall be selected by agreement between the parties. Unless the parties agree otherwise, they shall share equally the costs of mediation.

5. UOD and MAEER's MIT Group will respect the name and high reputation of each other, and will consult with each other regarding any publicity or external reference to this agreement.
6. This agreement will be valid for a period of three years from date of first signature. It may be extended or renewed by mutual agreement.

**MEMORANDUM OF UNDERSTANDING

Following discussions and the exchange of information between our two institutions, **Dr. Mangesh T. Karad, Secretary, MAEER's MIT Group of Institutes, Pune, India**, and **Dr. Rahul V. Karad, Vice President, MAEER's MIT Group of Institutes, Pune, India** and **Dr. Stephen Morgan, President of WESTMINSTER College, USA**, agree that a formal memorandum of academic exchange between the two institutions will be signed.

We will also explore the possibility of faculty and staff exchanges. The goals of collaboration on academic activities contained in this agreement include the following:

- To improve international understanding.
- To increase individual educational opportunities.
- To enrich the educational environment of both universities.
- To provide both societies with more and better information about the other country.
- To enhance the development of joint educational and research projects.

**1. Term of Conditions**

To implement the goals expressed above, the following is mutually understood and agreed: This agreement will serve as a general framework for academic cooperation between the two universities and is intended to facilitate the development of specific independent programs of collaboration in the future. Details of any specific activities will be developed mutually. The Memorandum of Understanding may, from time to time, have addendums attached to it with regard to such activities.

**2. Term of Agreement and Renewal**

This Memorandum of Understanding is effective upon signing by both parties. It may be amended at any time by mutual consent and will remain in effect for a period of five years. It can be extended by mutual consent of both parties. In the event of major revision or cancellation of this agreement, the host institution will provide current participants with the opportunity to complete their approved program.
