- b. The full amount of the grant sanctioned is being released as advance to the College/Institute.
- c. This sanction is issued in exercise of the powers delegated to the Council and other terms and condition laid down in the guidelines of the Scheme.

II. Limit of Funding

a. The grant from AICTE will be Rs. **1,00,000/-** (Rupees One lakh only) and the institute is required to make a contribution of **Rs. (400001 and above)** to the club (as committed by the institute in the proposal), non-compliance of which shall invite penal action.

III. Utilization of funds


