According to UDISE+ data of 2018-2019, out of 24,78,53,688 students learning in 15,51,000 schools/colleges across the India, 21,10,844 students are disabled persons. This data is of the students who have actually studying in different colleges or schools. According to the UNESCO report on India, 75% of children with disabilities won't attend the colleges for higher education. This issue creates due to many reasons but basically the important hurdle arises is barrier free environment.



#### **Objectives**


- 1. To ensure that students with disabilities get equal opportunities to explore their educational potentials.

and accommodation at the institute. It sets an environment that the disabled persons feel the right to equal access to education, freedom from torture and the right to Live with peers in the academic Community



# Ramps




In each and every building, at least one disabled friendly washroom is installed with all precautionary measures.


Wheelchairs are provided at every building for providing support for any physical activity if any disable person is needed.
