## ANTI RAGGING MEASURES

**Reference:** UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.

Formation of Monitoring cell, Antiragging Committees & Squads: Complying with the directive of the Honble Supreme Court of India and as per the UGC regulations, the Institute has formed Monitoring Cell, Anti-Ragging Committee and squads for overseeing the implementation of the provisions of the verdict with immediate effect:

#### Institute level Monitoring Cell:

A cell consisting of Director and senior Professors will monitor the anti-ragging measures adopted and precautions taken to eradicate ragging from the campus.

#### Anti-ragging Committee:

A committee Chaired by Dean Students Affairs consisting of faculty members nominated by the Director. The Chairperson of the Committee has constituted sufficient number of **Anti-ragging Squads** involving hostel staff, administrative staff and student representatives.

### Anti-Ragging Hot-line and Complaint Box:

Institute security control room Phone No. 020-30253510 will function anti-ragging hot-line of the Institute. Any complaint received on this line will be immediately passed on to the appropriate authority for action. A complaint box has been placed at the Reception of the Main building and hostel. Any complaint received in the box will be sent to Chair, Anti-Ragging Committee.

# Counseling of Freshers and Seniors:

Director of the institute and Dean Students Activities, will address the incoming students and senior students and make them aware of the seriousness of ragging and how civil and sensible it is to wipe out such acts from an Institute like MITAOE.

# Undertaking from Students and Parents:

Each student of the Institute and his/her parents and/or Guardian are hereby required to submit a combined undertaking at the time of registration, in the prescribed format, which is mandatory for registration.

It is imperative for all employees of the Institute (teachers, administrative staff, contract staff, caretakers, security staff, maintenance staff and cleaning staff) to report promptly any case of ragging/misbehavior that comes to his/her notice to a member of the anti-ragging committee or squads. All concerned officials of the Institute, students, parents and guardians of the students, members of Anti-Ragging Committees and Anti-Ragging Squads are hereby requested to adhere to the stipulations and effectively monitor and comply with the provisions made in the directives.
